5.0 Reports

5.1 Staff

Michelle - completed all host calls; sent email regarding the newsletter in hope of increasing readership; will encourage submissions from exec and commissioners etc; Conference call with ABOA on provincials process with hosts; volleyball – revenues over by \$5,800 and will subsidize next year; Inclusion Committee to meet soon with goal of creating a policy; Following up with hotels.tv; possible football summit/meeting to discuss changes to tiering and Alberta Bowl

John – provincial task force workshop; had noticed after the environmental scan there was no references to schoolcoach.ca or to CIAAA (and addressed with ASC); attended NIAAA conference – great networking. Has upcoming meeting with Milk and Subway to discuss future SUBWAY card fundraiser; Milk will do a one year initiative with ASAA around sportsmanship; attended SSC meeting in Ottawa where Athletics Canada came to meeting to address parasports and live streaming of XC and Track events in some provinces. Met with Federal Minister's Policy Director and Director General of Sport Canada re non-existent school sport funding at federal level.

Tyler - doing online courses; AIAAA reps presenting at seven teachers conventions in March: courses on social media and athletes & rejuvenation of an athletics program; attending HPEC in Banff for first delivery of 710C "Current issues in school sports"; Preparing for SIAAA conference in April, only have 25 registrations currently; pilot pgm to run courses in Ontario through OFSAA will be in May; BC is doing same format in February; Manitoba committed to doing similar events; NL working on finding funding for AD conference

Elyshia – attended the GAIN Educational session regarding the Casino; has been working on the yearbook; packing boxes for provincials, sorting banners; processing late registration forms

Mike – course sales summary was provided; next spike will probably be in August; has been working on Volleyball and Basketball courses, Volleyball course is ready to go and hope to launch it in February, Basketball is a huge course and took a week to go through and still needs a bit of work, but both courses are well done; SUBWAY cards are sold out, it has brought in approximately \$60, 000 for ASAA over 2013/14 and 2014/15; Track & Field Course still trying to find an author, lots of interest but no one is willing to commit the time; will work with Athletics Canada on a solution.

6.2 Game Limits

Discussion was had on possibly having game limits in all ASAA sports, not just basketball; game limits vary from province to province. Adding game limits would address ongoing concerns regarding tournament play and missing too much school; potential AGM discussion item.

ACTION ITEM: Create a spreadsheet to compare all the game limits for each sport in other provinces from across Canada to gather more information in order to bring it forward at the AGM for discussion (not as Notice of Motion)

6.3 Website Development RFP's

ASAA received 3 proposals back and has decided to go with Digital Echidna because of their good work with BC and Ontario's site redevelopment. It is felt that this company is better suited to the needs of our association; however, more funds are needed in order to use this company's services.

It was moved and seconded to use \$20,000 from SUBWAY Card Fundraiser to help pay for Web Development Project and potentially utilize funds from next year's SUBWAY fundraiser to make up any shortfalls. **MOTION CARRIED**

Discussion: Additional funds from the SUBWAY Fundraiser for this year, as previously discussed, include allocations to scholarships, schoolcoach.ca," Impact" sessions, legal fees, officials subsidy for vball and bball this year considering locations of events.

- Session topics will be: Positive Values & Perspectives, Sportsmanship & Respect, and Team Work & Healthy Lifestyles; Executive members will lead the sessions
