5.1 Staff

Deanna- Basketball was successful overall. Unfortunately there were a lot of livestream issues with 3A and 4A, who only received their equipment less than 24 hours before the event. The 3A host has requested to attend the AGM to give a presentation on her experience with SportsCanada.TV. Cheerleading starts tomorrow- there has been some growth in the sport. There has been some confusion about who qualifies for Provincials, and so some teams have dropped out as a result. Track & Field planning is going well. Coaching Life Skills course is well underway and should be done by June; discussion needed on which site this course will be hosted on.

Drew - No major financial updates. 68 registrants for CIAAA conference in Regina. The AIAAA Leadership Training Institute sessions will occur in Edmonton, June 22-23. Partnership with BC School Sport is a potential; currently discussing tentative options within this partnership to get BC on board.

Mike - Wrestling and Curling all went well. There were discussions at Rural Wrestling with coaches and they feel that it was a valuable part of their season. Based on this feedback, Mike recommends that we continue hosting the Rural Wrestling Championship. Medicine Hat did a fantastic job with Wrestling Provincials, especially considering they were hosting Basketball the following week. Curling went well overall. Next year's Curling Provincials are the same day as ACF Junior's; conversation needs to be had about potentially moving the the date a week earlier or a week later. Handball Provincials are coming up; the sport in general does not seem to be growing. Badminton Provincials are coming up after Handball; some concern about getting certified officials out to the event. AGM planning is coming along, award winners were notified,

registration is open. Mike will be attending the NFHS summer meeting this year. **Shanna** - Unified demo game at 3A basketball was fantastic, wonderful feedback from spectators, hosts and coaches. Boundaries need to be established and enforced with Unified coaches who are stepping onto the court and moving their athletes. Shanna is attending the Chestermere bean bag toss tournament that has 100 registrants. The growth of the Unified events in this Zone is overwhelming. Drayton Valley and Edmonton Metro both have upcoming events. Calgary Unified Basketball is May 23 at the Jack Simpson gymnasium. Para equipment has had a few hiccups with ordering and a few communication issues when working with other groups. The racing gloves have already arrived in addition to indoor training rollers. A researcher from the U of A and U of T are planning to do some work on the Unified program. Shanna started an instagram account for ASAA. She is also taking over the yearbook for this year and will be building a template to be used for future years.

John - Attended the Unified Conference in San Antonio with Shanna. John attended the Kainai 2A Girls championships and it was fantastic, the opening ceremonies was very unique. Ongoing discussions occurring regarding a wrestling eligibility issue, the school was issued a warning. John has joined a group that will serve to lobby for increased support for and funding of the sport and recreation sector. John attended the Central Zone meeting this week. Basketball Alberta wants to sign an MOU with ASAA but what will be included on that MOU is still being discussed. John spent a great deal of time working with Tim Schultz on modifying the Track and Field schedule to account for the additional pentathlon events.
