Current:

- E. A quorum will consist of two Directors and at least one voting member from a majority of ASAA zones at any general, special or annual meeting of the Board of Governors.

Notice #2: Policy – Article XIV –Amendments to Bylaws, page 25

Current:

- C. All items under Policy may be amended by a majority vote of the provincial Board of Governors. Proposed amendments must be submitted, in writing, to the ASAA office by April 1. The amendments to be considered will be posted on the ASAA website and available to all member schools at least three weeks prior to the Annual General Meeting.

- C. All items under Policy may be amended by a majority vote of the provincial Board of Governors. Proposed amendments must be submitted, in writing, to the ASAA office by April 1. **Proposed amendments of an emergent nature to be considered at the Annual Planning Meeting, must be submitted, in writing, to the ASAA office by September 1.** The amendments to be considered will be posted on the ASAA website and available to all member schools at least three weeks prior to the Annual General Meeting.

Current:

- 3. Online Coach Education
 - A. All member schools will be required to have at least one teacher coach or agent of the Board on staff who has completed the Fundamentals of Coaching online course, available at www.schoolcoach.ca, by **October 10**. Schools not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.
 - B. At least one team official (head coach, assistant coach or teacher sponsor) in all ASAA sports must have completed the ASAA's online Concussion course from www.schoolcoach.ca by one month into their respective Season of Play, this team official must be some one who is regularly present with the team during competition. Schools not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.

Note Penalties: ASAA Member School in non-compliance of sections A or B above will not be eligible to compete against other ASAA Member Schools in any ASAA sport, at any level (e.g. local, exhibition, regional, zones, provincials) until compliance is met.

- B. At least one team official (head coach, assistant coach or teacher sponsor) in all ASAA sports must have completed the ASAA's online Concussion course from www.schoolcoach.ca by one month into their respective Season of Play, this team official must be someone who is regularly present with the team during competition. Schools not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.
- C. **At least one team official (head coach, assistant coach or teacher sponsor) must complete the online "ASAA Bylaws and Policies Module" at schoolcoach.ca prior to being involved with his or her teams games. Teams not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee. Each member school will be assessed an annual fee as noted below and this would allow for unlimited participants to register for and complete the course at no additional cost:**

Rationale:

Same rationale as Option 2 below, but the small, per school, fee being proposed will cover the cost of developing, coding and hosting the new course, updating it as required, and covering monthly/annual hosting and maintenance costs for www.schoolcoach.ca. This scale also recognizes that the greater the classification, typically the greater number of coaches that would take the course and is fairer for the smaller schools to pay a lower fee.

Current:

If Notice #3 is successful then this notice will be withdrawn.

Proposed:

- 3. Online Coach Education
 - A. All member schools will be required to have at least one teacher coach or agent of the Board on staff who has completed the Fundamentals of Coaching online course, available at www.schoolcoach.ca, by **October 10**. Schools not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.
 - B. At least one team official (head coach, assistant coach or teacher sponsor) in all ASAA sports must have completed the ASAA's online Concussion course from www.schoolcoach.ca by one month into their respective Season of Play, this team official must be someone who is regularly present with the team during competition. Schools not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.
 - C. **Each coach involved in ASAA activities must complete the online "ASAA Bylaws and Policies Module" at schoolcoach.ca prior to being involved with his or her teams games. Teams not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.**

Note Penalties: ASAA Member School in non-compliance of sections A or B above will not be eligible to compete against other ASAA Member Schools in any ASAA sport, at any level (e.g. local, exhibition, regional, zones, provincials) until compliance is met.

Rationale:

This is proposed in order to protect student athletes, school Athletic Directors and Principals from ignorance of ASAA Policy by coaches which can, and has, resulted in penalties, both financial and otherwise against schools, athletes and coaches. It is logical to hope that any individual given the opportunity to coach students in the school setting be held to some level of account regardless of whether or not they are volunteers.

Currently there is a module at the end of Fundamentals of Coaching (FoC) - Unit 6 is on ASAA Bylaws and Policies. This module is five years old and needs updating. At the present time, only one teacher coach per school needs to take this

module by virtue of the requirement to complete FoC.

The plan is to separate Unit 6 from FoC. This achieves the goal of shortening FoC as well as making the Bylaws and Policy unit accessible, cost effective (est. \$3-\$6) and time efficient at 15-20 minutes. Requiring each coach to complete a brief course about the rules, policies, and functions of the ASAA is intended to assist schools insuring that all coaches have a minimum level of knowledge about high school sport and ASAA, and it is expected that late registration penalties on schools, currently over \$20,000 p.a could be significantly reduced. A resultant reduction in administrivia at school, zone and ASAA level is an anticipated outcome as well.

The nominal cost will cover course development and hosting. Over time, any positive cash flow is intended to develop a similar resource for parents (would be a free module).

Rationale:

AMENDMENT CARRIED

It is important that ASAA continue to be a leader in promoting SAFE participation in high school athletics. Concussions continue to be top of mind and other North American school sport jurisdictions have faced major legal challenges about their involvement in activities that put kids at risk of concussions. The concussion course is free – it takes about 20 minutes to complete, and it could save a life. This is not a burdensome policy to enact and it may be tough to justify to parents/guardians why such a policy is not in place to protect those dear to them. Current ASAA policy requires one coach on every team to complete this course. This policy expands that and will have the biggest impact on teams with multiple assistant coaches.

Notice #6: Policy – Section IV- Eligibility, page 37

Current:

ASAA Executive Committee

The principal of each school shall be responsible for the eligibility of the school's competitors for any competition. The following rules regarding eligibility will apply to all ASAA sponsored activities.

A. Student Eligibility

- CARRIED
1. Subject to the provisions of the transfer policy found on pages 45-51 inclusive, in the case of transfer from one school to another the student shall become a bona fide student in the new school upon the date of their first attendance at classes following the acceptance of this transfer in by the principal, provided however that the principal's decision to accept the transfer-in shall not in any way affect or derogate from any decision that the ASAA may make relating to the eligibility of the student to participate in ASAA sponsored activities.
 2. The student must register in a minimum of 800 instructional minutes (i.e. 10 credits or two full time courses) per week during the time of participation in that activity for which Alberta Education credits are granted. Distance education courses can be considered as regular instructional minutes.
 3. A student who becomes 19 before September 1 shall be ineligible for high school competition. Note: A student who becomes 19 on or after September 1 shall remain eligible for the entire school year.

4. a. Subject to the provisions of the transfer policy found on pages 45-51 inclusive, every student has the right to their choice of school for their grade 10 year. Students shall be eligible for three consecutive years after registering in grade 10. The first year in grade 10 is considered the first year of eligibility

Proposed:

The principal of each school shall be responsible for the eligibility of the school's competitors for any competition. The following rules regarding eligibility will apply to all ASAA sponsored activities.

A. School Eligibility

1. The Principal will require each student and their guardian to complete and sign an Acknowledgement and Agreement Form confirming that all required parties are aware of ASAA Bylaws and Policies; will accept that any application for a review of an outcome of an appeal process of the ASAA or the respective zone by a Judge in a court of law must be brought by the administration of the school and not by the student/guardian. These forms must be completed and kept on file, with copies being provided to the ASAA only if requested, and for a reasonable purpose.
2. The Principal of each school will sign an Acknowledgement and Agreement Form which: confirms their membership in ASAA; that school coaches will abide by ASAA Bylaws and Policies; that membership in that school's zone and the ASAA is a privilege, not a right; that the outcome of any appeal process of the ASAA or zone is final and binding on the administration of the school; that violation of Bylaws or Policies of the zone or ASAA or of the Acknowledgement and Agreement Form may be cause for expulsion of the school from the zone or the ASAA.

B. Student Eligibility

1. Subject to the provisions of the transfer policy found on pages 45-51 inclusive, in the case of transfer from one school to another the student shall become a bona fide student in the new school upon the date of their first attendance at classes following the acceptance of this transfer in by the principal, provided however that the principal's decision to accept the transfer-in shall not in any way affect or derogate from any decision that the ASAA may make relating to the eligibility of the student to participate in ASAA sponsored activities.
2. The student must register in a minimum of 800 instructional minutes (i.e. 10 credits or two full time courses) per week during the time of participation in that activity for which Alberta Education credits are granted. Distance education courses can be considered as regular instructional minutes.
3. A student who becomes 19 before September 1 shall be ineligible for high school competition. Note: A student who becomes 19 on or after September 1 shall remain eligible for the entire school year.

Rationale:

Almost three years ago the ASAA was in court for the fourth time in 20 years. Legal challenges are very expensive for the ASAA and have an impact on the member schools to be able to enforce ASAA Policy. Having such a policy in place acts to protect the Athletic Director, the Principal/school, the zone and the ASAA in the event of a threat of legal challenge. Edmonton Metro enacted this policy two years ago and it has been very well received. In at least one case, a potential court challenge was avoided because the school stood by the form that the parent signed.

Notice #7: Policy – Section IV – Eligibility, A. Student Eligibility, page 40

Current:

Participation on a Non-School Team

2. To be eligible for high school provincial competition in the ASAA sports of basketball, volleyball, football, cheerleading, team handball and rugby, a high school student is not permitted to play on a non-school team in the same sport during the same season. Where a community/club basketball program exists, students are permitted to play for the community/club basketball team while trying out for an ASAA member school

team but can no longer play for the community/ club team as of the school team's first game or midnight of the Saturday of volleyball provincials, whichever comes first. Where a community or club/tour team in rugby exists, students are permitted to play for the community or club/tour team while trying out for an ASAA member school team and can participate on an interschool team for the purpose of touring during designated spring breaks. Otherwise, after March 15, no students can participate on any community/club team or non-school tour.

Proposed:

Participation on a Non-School Team

1. To be eligible for high school provincial competition in the ASAA sports of basketball, volleyball, football, cheerleading, team handball and rugby, a high school student is not permitted to play on a non-school team in the same sport during the same season. Where a community/club basketball program exists, students are permitted to play for the community/club basketball team while trying out for an ASAA member school team but can no longer play for the community/ club team as of the school team's first game or midnight of the Saturday of volleyball provincials, whichever comes first.

In Rugby, students are permitted to play on a club/tour up until ~~March 15th~~ the conclusion of the Canada 7's rugby tournament while still trying out for an ASAA member school team. Otherwise, after March 15, no students can participate on any community/club team or non-school tour. After ~~March 15th~~ the conclusion of the Canada 7's rugby tournament students are only permitted to play for their respective school team or an interschool touring team that will travel during designated spring breaks.

Rationale:

With the new rugby 7's international tournament being approved in Canada for the next three years, teams are focused on attending this tournament as it offers national exposure. Students should be allowed to travel to these types of tournaments before the March 15th deadline. After that date they are limited to participating only with their school teams.

Notice #8: Policy – Section IV – Eligibility, A. Student Eligibility, page 40

Current:

Grade 9 Students

1. In 1A classified onsite schools, grade 9 students attending those member schools, may be registered for team participation in basketball, volleyball, curling, cheerleading, team handball and golf. Grade 9 41 students are not eligible for athletic participation in individual sports or on the senior varsity teams of 2A, 3A or 4A classified schools. Exception would be for athletes from 1A schools that opt up to 2A or are teams that are 99 or less in a joint school team.
2. Onsite grade 9 students in member schools, playing on junior varsity teams of 2A-4A schools are permitted to play in any games (league or tournament) against ASAA member school senior varsity teams.
3. In football only, onsite grade 9 students in member schools are eligible to participate on teams at the tier IV classification and on all 6-man teams.
4. In cheerleading and curling only, onsite grade 9 students who are registered as students of an ASAA member school, regardless of classification, are eligible to participate on the competitive school team with the consent of the principal and athletic director.
5. In rugby only, onsite grade 9 students in member schools are eligible to participate on 1A and 2A school teams.

Proposed:

Grade 9 Students

1. In cheerleading and curling only, onsite grade 9 students who are registered as students of an ASAA member school, regardless of classification, are eligible to participate on the competitive school team with the consent of the principal and athletic director.
2. In 1A classified onsite schools, grade 9 students attending those member schools, may be registered for team participation in basketball, volleyball, team handball and golf. Grade 9 students are not eligible for athletic participation in individual sports or on the senior varsity

teams of 2A, 3A or 4A classified schools. Exception would be for athletes from 1A schools that opt up to 2A or are teams that are 99 or less in a joint school team.

3. Onsite grade 9 students in member schools, playing on junior varsity teams of 2A-4A schools are permitted to play in any games (league or tournament) against ASAA member school senior varsity teams.
4. In football only, onsite grade 9 students in member schools are eligible to participate on teams at the tier IV classification and on all 6-man teams.
5. In rugby only, onsite grade 9 students in member schools are eligible to participate on 1A and 2A school teams.

Notice #9: Policy – Section IV – Eligibility, E. Transfer Policy, Establishing Eligibility, page 45-51

Current:

See E. Transfer Policy (Athletic Eligibility following transfer from one school to another) page 45-51

Proposed:

5. Transfer Policy—Eligibility of Students Transferring Schools

- A. Students who transfer schools, after beginning grade 10, either within Alberta or come into Alberta from another country or province, are **ineligible** to participate in any ASAA activity for twelve months from the first day of attendance at their new school **or until** the eligibility of the student to participate in ASAA activities is approved according to this policy.

This policy **applies** when a student has participated in one of ASAA's 12 listed activities, regardless of location (in province/out of province).

This policy **does not apply** to students who did not participate in **any** of the ASAA's 12 listed activities in their previous school.

- B. The receiving school principal, with the agreement and consent of the sending school principal, can approve eligibility for the transfer student to participate in ASAA activities if the receiving school principal validates the transfer is for at least one of the reasons listed below.

N.B. The student must also be eligible for participation in ASAA activities according to all other ASAA eligibility policies. This policy does not apply to any other question of eligibility such as fourth year eligibility.

Accepted reasons for approving eligibility for transfer students:

1. If student has not participated in any activity which is the same as an activity sponsored by the ASAA in their previous school for a period of twelve consecutive months before the date of transfer the receiving principal may use this reason to approve the student's eligibility. The receiving principal must still follow the online application procedures set forth in the [Administrative Addendum for Transfer Policy](#).
2. Change of residence:
 - a) **Parent to parent move:** the student moves to reside with the parent with whom they have not been living and is required, as a result of this move, to transfer schools. Eligibility will be permitted for a **maximum of two** such transfers during a student's three years of eligibility. The residence of a student shall be that of the parent to whom custody has been awarded by a court of competent jurisdiction. If no custody order has been entered, the residence shall be that of the parent who had custody immediately upon the separation.
 - b) **Family move:** the student has moved with the parent(s)/legal guardian(s) who have changed residence within the previous 12 months to reside within the catchment area or normal boundaries of the school at which the

student has registered. Any change in residence must be bona fide. In order for a change of residence to be considered bona fide, at least the following facts must exist:

- i. The original residence must be abandoned as a residence; i.e., sold, rented or disposed of as a residence and must not be used as a residence by another member of the family.
- ii. The entire family must make the change and take with them the household goods and furniture appropriate to the circumstances.
- iii. The change must be made with the intent that it is permanent.
- iv. The student is ineligible to compete for the receiving school until the actual change of residence has occurred.

- c) Under no circumstances can a student have more than one residence for ASAA eligibility purposes. School officials are obligated to know the residence status of each student and to require compliance with these requirements.

3. Directed by Legal Authority

- a) The student is directed by legal authority to move from their current school to a different school.
- b) Legal authority shall include but not be restricted to:
 - i. a court of competent jurisdiction;
 - ii. any department or agency of the provincial or federal government acting within the scope of its authority or pursuant to an order of a court of competent jurisdiction;
 - iii. any school board or school authority acting within the scope of its authority or pursuant to an order of a court of competent jurisdiction.
- c) A student whose custody has been established by court order or social service agency decision is eligible for participation at the school to which he or she is assigned by the respective court or social service agency.

4. If a student transfers schools because an educational program is not available at his/her current school and is available at another school this is an acceptable transfer reason for ASAA eligibility. It must be **verified in writing** by the sending principal that the educational program is not available at the student's current school.

5. A reason based on religious grounds which is explained in writing by the student and acknowledged by the parents/guardians in writing must be presented to the receiving school principal who then determines if the reason appears sufficient to apply for eligibility of the student to participate in ASAA sponsored activities.

6. If evidence of mental health issues, including but not limited to bullying or an abusive home life is presented by the student to the receiving principal as a reason for transferring schools then the receiving principal is to contact the Compliance Officer for direction and assistance in determining the eligibility of the student to participate in ASAA activities.

C. If reasons or circumstances for approving eligibility do not appear in this policy then the receiving principal is encouraged to contact the ASAA Compliance Officer for clarification, assistance or a ruling on evidence presented to the Compliance Officer per the Compliance Officer's direction.

D. In the event the sending school principal and receiving school principal do not agree on the eligibility of the transfer student either can request the intervention of the ASAA Compliance Officer for assistance, mediation and clarification of ASAA eligibility policy.

E. Pursuant to the intervention of the ASAA Compliance Officer as noted in D above, if agreement by the involved principals can still not be reached then the ASAA Compliance Officer shall determine the eligibility of the student to participate in ASAA activities in his/her new school.

F. The decision of the ASAA Compliance Officer may be appealed by either or both school principals. ASAA Policy Section VII – Appeal Procedure page 71 of the ASAA Policy Handbook is to be followed in the event of an appeal.

If any member school of the ASAA is dissatisfied with the application or interpretation of the Transfer Policy 5 or believe there are other circumstances that need to be considered in a specific case then the member school can appeal the eligibility decision for the specific case to the Executive Appeal Committee per Policy Section VII – Appeal Procedure.

Note: this process bypasses the Zone, Executive Director and Compliance Officer.

- G. If an ASAA Zone has unique circumstances, for example: designated schools or school boundaries, the respective Zone can and is encouraged to develop and implement Zone based transfer policies and procedures that respond to these unique circumstances. This must be done in accordance with Article III-4 (page 15, 2016-2017 ASAA Handbook)
- H. See the [ASAA Administrative Addendum for Transfer Policy](#) for procedures, forms, examples and timelines required to determine ASAA eligibility of students who have transferred from one school to another.

Rationale:

There continues to be great dissatisfaction with the ASAA’s current transfer policy. Following input from the transfer committee, ASAA legal counsel, the ASAA Executive Committee and the ASAA Board of Governors, it has been decided to put more authority back in the hands of sending and receiving principals regarding acceptance of transfers. The online process will still occur and the Compliance Officer will still be in place, but the principals of our schools will and should play a larger role in this process. Any disputes will go to the Compliance Officer and/or the ASAA Executive Appeals Committee. This policy change should make way for a more streamlined process.

Notice #10: Policy – Section IV – Eligibility, E. Transfer Policy, Establishing Eligibility, page 47-48

Current:

- 3. In the event that a student cannot satisfy the requirements for athletic eligibility as set out in paragraphs 1(a), 1(b), 2(a) or 2(b), and the student applies for athletic eligibility citing 'other' reasons, then:
 - a. The ASAA may determine the transfer was athletically motivated and the student will not receive ASAA athletic eligibility.
 - b. The ASAA may determine the transfer was not athletically motivated and the student will not be eligible for any ASAA sanctioned sport that the student participated in during the previous school year at the sending school. The student will be eligible for any ASAA sanctioned sport that the student did not participate in during the previous school year at the sending school. Rule (3b) will be postponed until 2016/17 OR
 - c. In extenuating circumstances, the ASAA, in its absolute discretion, may determine a student to be eligible for all ASAA sanctioned sports. Examples of extenuating circumstances may include, but not be limited to:
 - i. Substantiated and documented bullying
 - ii. Substantiated and documented abusive home life and student moves in with friends or relatives

Rationale:

Was not supported by a significant majority of the ASAA Board of governors in an emergency vote in the fall of 2015 and was postponed for implementation in 2016/17. Rationale:

Athletics in an educational setting at the school level has a number of philosophies including: education first, equitable opportunity, fair play, safety of students and more. This policy proposal is intended to support student safety and to promote athlete development without compromising time spent in the classroom. The following comments provide rationale for this policy change:

ASAA already allows a maximum number of 36 games in basketball to be played before playoffs begin. From an LTAD point of view playing too many games presents too high a game to practice ratio and needs to be reduced. While an initial proposal of 28-30 games was made, the ASAA Board felt 34 games was a more reasonable expectation based on current league and tournament play. At the same time, as there are no limits in any other sports, it is only reasonable to expect that the same philosophical position taken on basketball should apply to some other ASAA team sports. In volleyball, given that the number of games played per day is higher than basketball, “day of competition limits” instead game limits have been proposed. Both football and rugby folks have indicated that meeting the game limits will not be an issue.

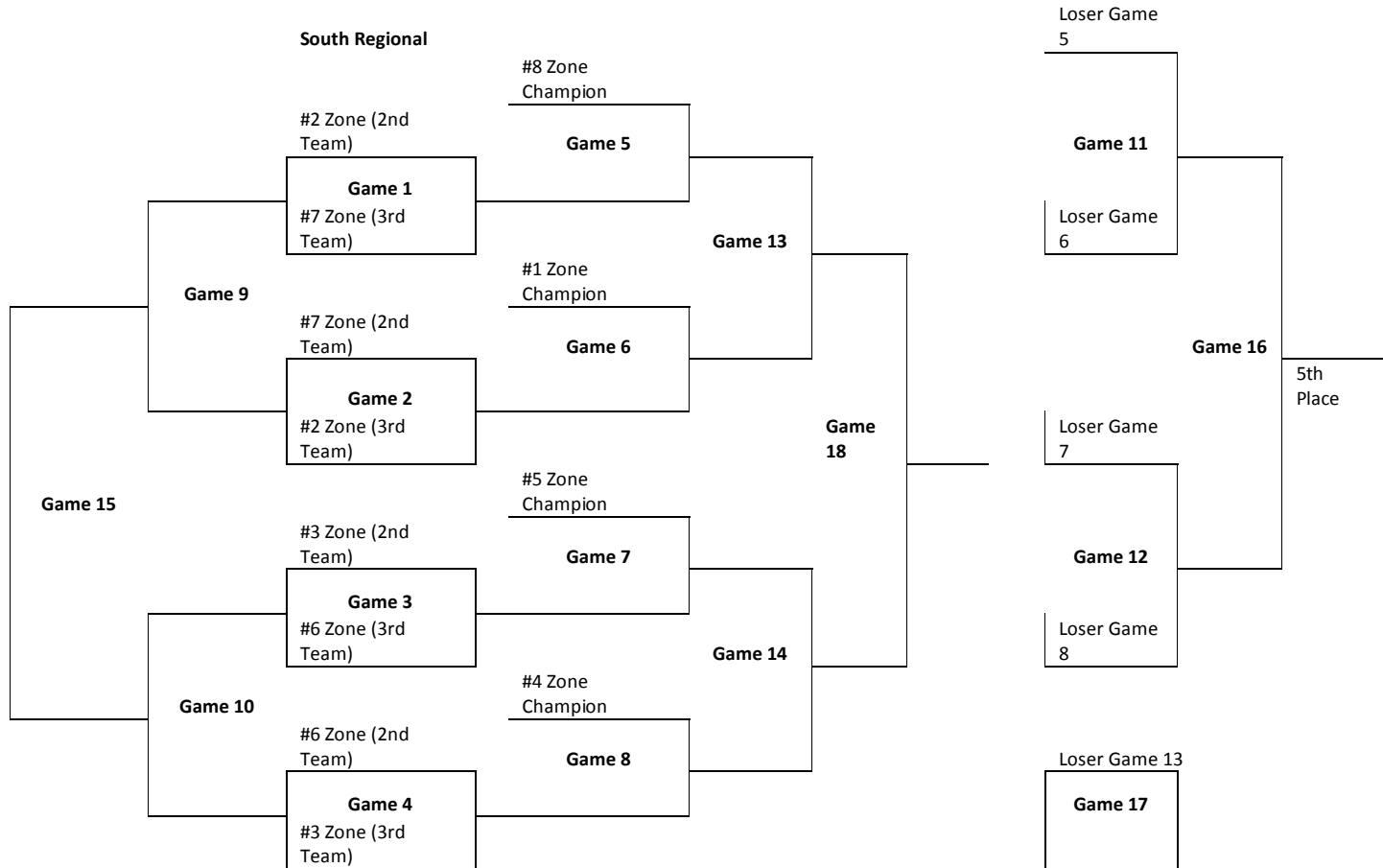

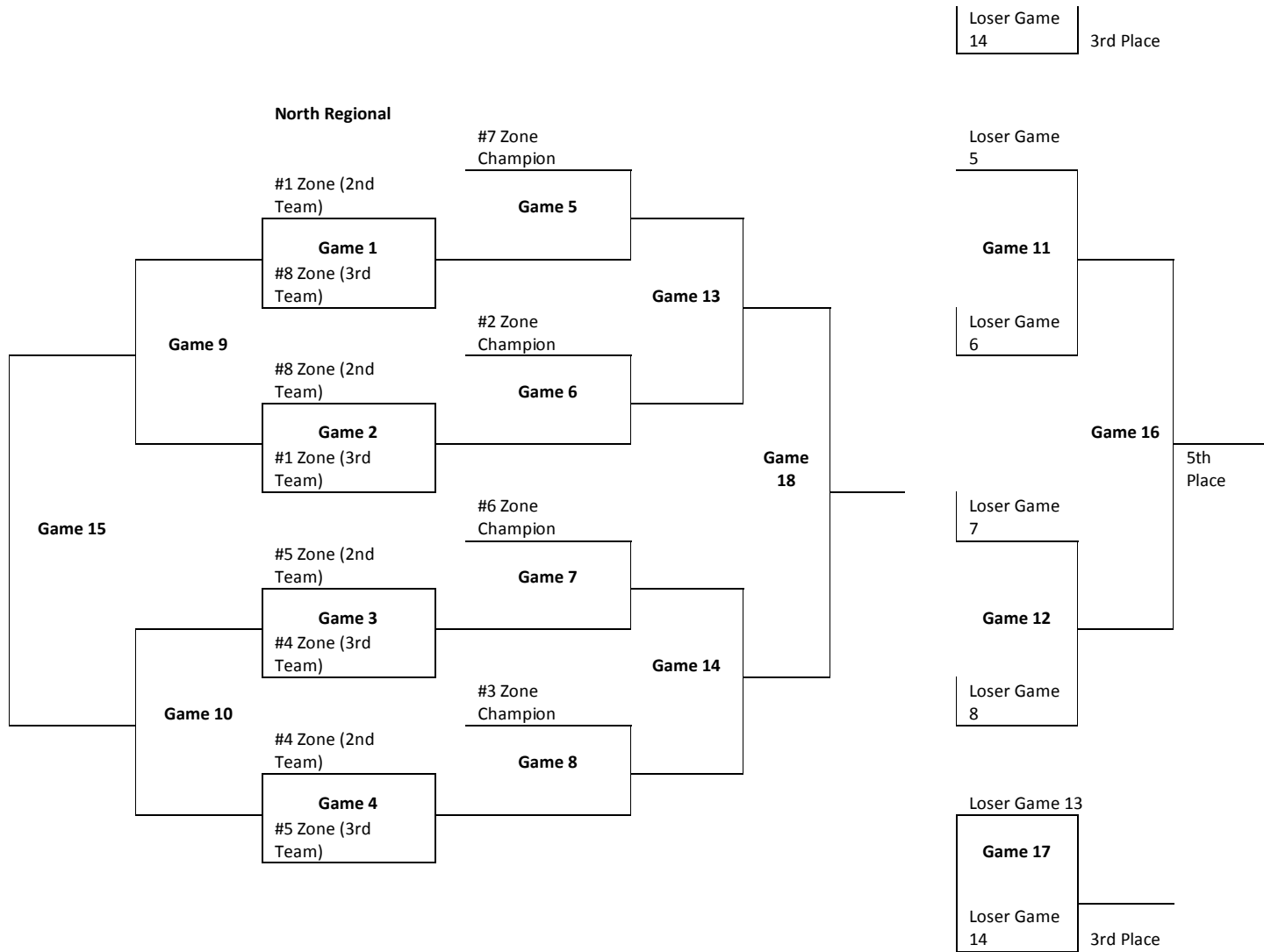

It has proved quite difficult for people to grasp how cheerleading divisions work when those numbers are reversed on them. The suggestion of using the word "Level" instead of "Division" allows the sport of cheerleading to have its numbering remain consistent at all of its age levels and avoids the confusion with the word "division". I believe this to be an appropriate compromise to allow the uniqueness of cheerleading to be respected. I know it is important to the ASAA, member leagues, and of course member schools, that Cheerleading continues to grow as a sport across the province. I think the current division names have a negative effect on that. All of this is with the main goal of garnering as much support and respect as possible from staff, students, and spectators for the coaches and athletes that work so hard each year to be successful in competitive cheerleading.

Judges for zone and provincial competition shall be chosen by the ACA Technical Coordinator.
4. Scoring Process: All penalties given during the competition routine will be deducted from the total score to calculate the team's final scores.
5. Tie Breaker Policy:
 - a. The team with fewer penalties
 - b. If the teams are still tied, they will be considered tied in the final rankings
 - c. In the event that all ACA tie-breaking methods have been exhausted at the championship, awards will be given to all teams with the top three scores.
6. At the provincial competition an award (plaque) shall be given to the best novice team in the competition according to the following criteria:

7. The ASAA recognizes the ACA as the official training and certifying agency for the cheerleading judges in Alberta. The ASAA cheerleading host will use only ACA- approved judges at the ASAA Provincial Championships. 8. SCORE CHECK: All Provincial Championships will have a Score Check station in place.
9. All judging decisions are final. If you have a concern regarding the judging results, the following steps should be taken:

The Provincial Championship for the Junior category is the first week of January. The National Championships is the last week of January. The Provincial Championship for the U18 category is the first week-end in March, the same as the ASAA Provincial Championship. Efforts by ASAA and ACF to change this conflict have not been successful.

1. Schools should have the opportunity to showcase their best team and individuals in all sports. There are no restrictions placed on any other ASAA sanctioned sport whereby students playing on provincial or national teams are not allowed to play on their school team.

Rationale:

In an attempt to allow more teams the chance to compete at Provincials but also maintain a high level of competition at the championships, there needs to be a change in berth allocation.

Due to the recent changes to the Calgary and Edmonton Zone leagues, the ratio of teams eligible to compete at provincials and the berths per zone has changed drastically.

In Calgary & Edmonton, all 4A schools used to be able to declare an intent to qualify for Provincials and at the start of the year they all had an opportunity to do so regardless of the tier or division they played in. However, now in Calgary only teams in Division 1 are eligible to qualify for provincials and in Edmonton only team choosing to participate in Tier 1 are eligible. When you look at eligible teams (those with a chance to qualify for provincials) and the berths for each zone, Calgary and Edmonton have a much higher chance to qualify for Provincials with their new qualification process. This equates to having only around 8 teams per year in each zone (8 in Calgary and 7-9 4A teams in Edmonton depending on how many teams choose to play in tier 1) vying for 3 berths compared to the 10-15 teams vying for 3 berths in the old system.

Percent of Zone Qualifying for Provincials under proposed berth allocation

- Calgary: 25% (2 of 8 teams)
- Edmonton: 22-29% (2 of 7-9 teams)
- Central: 25-33% (1 of 3-4 teams)
- South: 25-33% (1 of 2-3 teams)
- South Central: 33-50% (1 of 2-3 teams)
- North East: 50-100% (1 of 1-2 teams)
- North West: 33-100% (1 of 1-3 teams)

The creation of 2 wildcards will not take away the ability of the 3rd place teams in Edmonton and Calgary from qualifying for provincials, it simply allows a maximum of 5 other teams the chance to qualify as well. As per the volleyball wildcard selection policy, the best team from each Zone who does not qualify for Provincials are eligible to be selected by the ranking committee, commissioner and ASAA based on their season of play and strength of their zone.

Rationale:

The playoff draw for the 4A Volleyball Championships plays out every position. I am proposing that this playoff draw is brought in line with all other volleyball championships in that they do not play out every placing. Due to the inclusion of a round robin, it is unnecessary for teams to play out every position. The 4A Provincial results are not used for wildcards berths for next season, nor do they affect rankings the next year. Having 2 teams lose 3 games in a row (in the playoffs) to end their championship seems excessive. It would mean that the 4 teams playing for 7th and 11th place would only play 5 matches (4 best of 3 and 1 best of 5) instead of 6 (5 best of 3, 1 best of 5). This is similar to other volleyball championships where teams may only play 4 or 5 best of 3 matches in the round robin before they are eliminated from competition. In some cases, the elimination of these games may help a team with longer travel or travel in adverse weather conditions depart the championships earlier, thus arrive home safer.

Too many matches in one day leads to a greater chance of injury in the later matches, given this is a qualifying event we do not want to increase chances of injury for Provincial Finals.

- iii) ~~In a three way tie for second place, the players will be ranked 1, 2 and 3 as described in ‘ii’ above. The second and third ranked players will play one game to 21 points to determine who will play the first ranked player in one game to 21 points that will then determine second place in the round robin.~~
- iii) **If there still remains a tie between two teams in games and points, then we will revert to head to head between the two tied teams.**

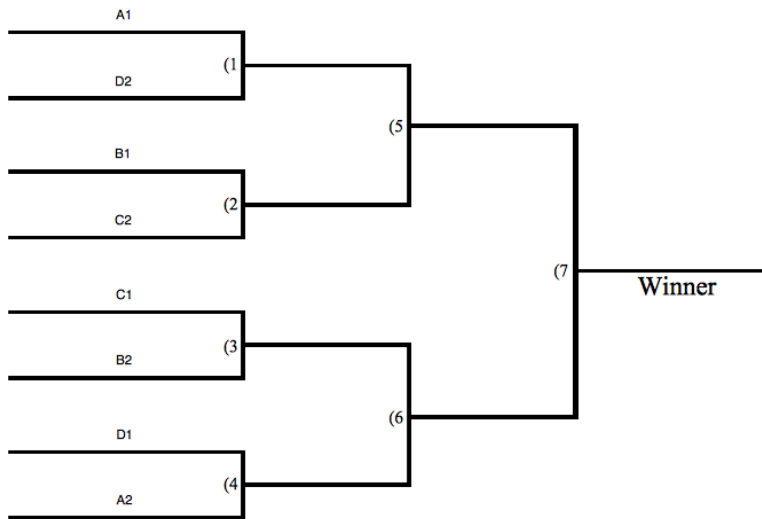
d) Playoffs

~~There will be separate playoffs for Category A and Category B. Each category has two pools of 4 (A and B). At the end of the round robin matches, the top two finishers in Pool A and Pool B will enter the playoff round. First place in Pool A will play second place in Pool B, while first place in Pool B will play second place in Pool A. the winners will play for gold and silver medals while the losers will play for bronze (all playoffs will be matches).~~

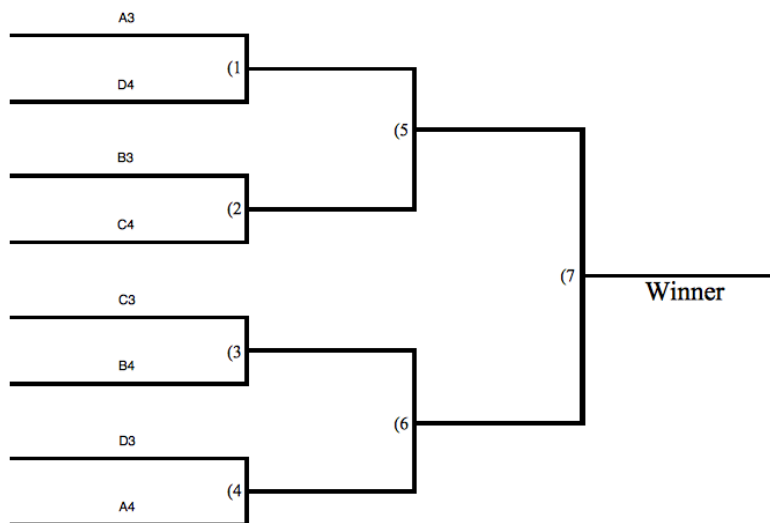
There will be separate playoffs for Category A and Category B. The 1st and 2nd place finishers in each of the pools will go to the Category A Playoffs. The 3rd and 4th place finishers in each of the pools will go to the Category B Playoffs. There will be a GOLD, SILVER and BRONZE MEDAL for each Category. (See the playoff structure below)

f) Scoring

- i) The winning school in each classification, 1A, 2A, 3A and 4A shall be the school with the greatest number of points awarded. **Schools/teams will get one point per match win in the Round Robin.** Schools/teams will get two points per match win in Category A **Playoffs** and one point per match win in Category B **Playoffs**.

- ii) In the event of a tie between two or more schools when determining the school team champion, the tie will remain and each school shall receive a champion banner.

Rationale:

Positives from Last Years New Format

- We added a second doubles team and a second mixed team which gave more exposure to more athletes
- Format was consistent across ALL disciplines. And this is important when you are dealing with this many athletes/matches
- We removed the seeding game in singles which prevented throwing of matches and seeding was always a headache
- We made Category A weighted more than Category B

Drawbacks from Last year

- As we expected by putting 1st place finishers in Category A right away and 2nd place finishers in Category B right away this created many lopsided matches in both Categories. The intent of Category A and B is to give everyone meaningful and quality matches. This is what we need to improve somehow! This year, junior nationals do not conflict with high school provincials, so there will be many more matches like this for this year as well.
- As well whether or not it happened or not there was potential for throwing matches at the zone level now because teams wanted to be the 2nd seed.

Information about New Possible Format

1. **Number of matches:** It does not add any extra matches on the Saturday. It does add an extra 120 matches on the Friday. But split amongst a few facilities and the fact that time never is a problem on the Friday it should be fine.
2. **Number of matches for each athlete:** Right now many athletes go all the way to provincials and only play 3 matches. And for many they play their first 2 matches and may already be eliminated from playoffs. This format will see everyone get a minimum of 4 and a maximum of 6. They would play 3 round robin matches on the Friday and a potential of 3 playoff matches on the Saturday. The playoff matches are allotted more time and I don't think it is too many matches for the athletes.
3. **The Proposed Format:**
 - a) Allows any player that qualifies for provincials a chance to still compete for a Gold Medal in Category 1 and also allows for more even matches.
 - b) Ensures that each zones 1st place will not play the same zone's 2nd place in the round robin or the first round of the playoffs. As well it ensures that you will not play someone in your original pool again unless you both make the finals.

The draw was set up using a standard 4 pool system and we used last year's results (unbiased).
