Elyshia: enjoyed her holiday to Mexico; checked Volleyball Eligibility and there were no late registrations to be done; working on sanctioning tournaments and getting those posted onto the website (there are quite a few that are coming in under the minimum 30 day requirement as outlined in the policy handbook); working on finding the last few volunteers for the SASS Casino; getting ready for APM; completed mailout of yearbook and the school directory.

John: met with Tom, Dean and Michael K to discuss the handbook review; thanked Dave and Harry Ainlay for hosting Impact this year; had a few meetings with ASC re final edits AB Sport Plan; John wrote a letter to Education Minister David Eggen to inform

him about ASAA's transgender policy in light of recent media attention to transgender students; attended meeting on Blood Reserve in Kainai re Makeadiff grant and keeping indigenous students in school via sport; met with Joyce, Elyshia and Shanna about the 60th Dinner; met with game limits committee and came up with recommendations to discuss at APM; Milk Scholarship Banquet - the winners were not available but John heard a new program from Dairy Farmers of Canada "Fuelling Women's Champions" and has met with Milk to discuss opportunities. Had a few challenges with 4A Volleyball host school and will be following up accordingly.; Football provincials were excellent. Following up on one disciplinary issue. Attended 3A girls Volleyball to see finals and present awards.

Mike: course sales are really good still; Dave has been speaking with schools in Edmonton about the Calgary Mandate for the FoC and the possibility of having this happen in Edmonton; ran a promo purchase AIM course – get the FoC for free which generated some interest; assisted at Football Provincials; working on the new website **Josh**: Volleyball and Football Provincials have wrapped up and there were not too many concerns; web streaming was a big hit, and there were lots of hits on twitter; some struggles with the Nutrition Policy and trying to get it to work well (3A Girls lost some money on their concession) and need to find a better way to work with our hosts on this; good feedback from !MPACT; new website is coming along and the championship sites should be up for Basketball at the end of January; along with John met with Ryan at Volleyball Alberta about the high costs of officials for Provincials.

Shanna: is working with Jasper Place to start Unified Sports in February; working on getting some promo items made which is moving a bit slowly; hoping to get a few more schools on board and expand them through the 2015/16 year; Unified Sports will be starting with Basketball.

6.2 !MPACT Workshops (evaluation summary)

Josh sent out a survey to the Athletic Directors that had students at the !mpact Workshop and got an underwhelming response; we need to strategize about how to get feedback in a timely manner – day of survey, done before they leave; Josh would rather see the thoughts on the individual sessions so that we know if we need to tweak sessions or get rid of sessions; need to better engage the advisors that are attending the workshop

ACTION ITEM: change the name of the Mental Health Session (Sport Psychology); Offer session to advisors on how to deal with athletes who are suffering from Mental Health Issues.

ACTION ITEM: talk to Ken Zelez about leading a Sports Psychology/advisor mental health for athletes session(s) at the Spring !mpact Workshop

6.3 Schoolcoach.ca: meeting with 77 Media Mike and John met with Athletics Alberta about track course and approaching the 2001 IAAF Edmonton legacy Committee with a financial request to help aid with the building of the track course; Athletics Canada will be authors of all future courses; ASAA looking at best way to spend limited funds in light of Cenovus leaving; 77 Media is willing to work with us to get the courses running the way we want them to be; pulling out the ASAA Bylaw and Policy section of the FoC course to be its own 10-15 minute module which we would like to see mandated by the board for every coach to take. Potential to offer this service to other provinces (their expense to develop) through schoolcoach.ca

6.4 ASAA Policy Handbook Review & Transfer Policy (Michael Keyes and Dean Rook) The committee looked at the handbook to review its functionality, and if people can easily find the information that they require – the committee feels that the current edition does that. The handbook is 60 years old, and each year, policies are added or updated, same with important information. Dean Rook has found some inconsistencies which are minor and he has noted for us. Regarding the Transfer Policy, discussion was had on how to reduce legal issues that can arise from the handbook, especially this policy. The objective is to keep as many kids in sport as we can. Work continues on this project.
