Suggest allocating funds annually, from an increase in membership fees – there has been no increase in fees in three years. Will take several years to achieve contingency; Salary and benefits will increase in 2014/15 due to contract negotiations. Suggestion to build scholarship fund contribution from annual budget. A membership fee is required to achieve 2014/15 and beyond goals. Suggestion was to bring two choices to board for vote, following a survey to all schools

Volleyball Championship Committee recommends to allocate \$5,000 more to online program template development; \$5,000 towards officials costs for 2014/15 vball considering anticipated increases in officials' costs because of 5 locations being in NE zone. Remaining profits to be allocated to the setting up of a scholarship fund for student athletes who are also involved in coaching or officiating in school or community sport; somewhere above \$17,000 towards initial goal of raising \$100,000. 5.1 Staff

Ian: Calgary unique in that the closed borders system, Ken would like to present the actual numbers to the Zone as it may actually let them see that their zone has a huge number of transfers. Create a one pager for the website on when a transfer is required. Discussion on proposed transfer policy Notices of Motion (report provided) Mike: Ambassador program – funding from Cenovus can now allow for initiative moving forward, had a call with the Ambassadors; they will review the schoolcoach website and get information so that they can start promoting; shooting skills video for volleyball and basketball in 2 and 3 weeks; need basketball student athletes for a Tuesday and Thursday but will be the same week as Provincials. Will provide details to Exec. April in Indianapolis to shoot onscreen presenter videos. NFHS is allowing ASAA to use their updated version of Fundamentals of Coaching, which can also be use on tablets unlike the original version – Mike to work on course updates. iPad, etc as the platform is different than what we use and more accessible; www.schoolcoach.ca now live; at SWATCA (9 attendees), Central Alberta (4 attendees) and SEATCA teacher's conventions; accreditation moving forward, waiting for quote from Creative Street; chart on sales to date provided; only 6 ASAA member schools have not completed Fundamentals of Coaching

Fiona: Rural wrestling provincials, awarded the sportsmanship pins during the ceremony good recognition the students; did social media while at events; changed ASAA logo to pink on website to recognize Anti-Bullying Day; Play Around the World May 2 leaving so will not be able to attend AGM and Badminton provincials; ASAA social media can be used for member schools to promote links and discussion items for view. Fiona can use it for the crowd start up or for promoting the equipment for Play Around the World **Tyler:** a written report was provided and reviewed. Great initiatives around the CIAAA, NIAAA and IIAAA. Grant application submitted for CIP re flood assistance for loss on AIAA conference; timeline to submit was short.

John: NFHS Citizenship and Equity had presentations on transgendered student policies – John will have policy to present to Executive before the April 1 deadline; John and Dave Jones met with Dave's MP re support for School Sport Canada – goal is to ask Federal ministers and other MP's to write letter of support for SSC in its goal to obtain funding from Sport Canada; went to BC and met with some AD's who want to start an athletic administrators association, which will also translate into revenue for AIAAA through course royalties; shared his written annual submission (several documents) to Alberta government re ASAA activities/accountability; had hoped to get an agreement with Wingate for AGM but they only have single rooms and it would cost too much. Feedback from membership was to not go back to the Courtyard Marriott for AGM; Don Horne has had some feedback from TELUS to facilitate an application for sponsorship; Olympics press release on ASAA athletes was noted; Alberta Sport Plan meeting postponed; board position with the Alberta Sport Connection available (Marg McCuaig-Boyd and Tim Main sent in resumes)

Free courses always have better uptake. Executive/Mike thoughts on approaching school boards to pay some sort of fee that allows access for their members to take the courses, though there would be to be a limit on the Fof C as there is a licensing fee that has to be paid to NFHS for each FoC course taken? Another thought needing feedback buy Legal and get Safety Guidelines(?) or any other course(?) for free? Bundle the courses? With feedback from the Executive Mike will come to next meeting with a proposed promotion for students and another for the teachers

John suggested he present a webinar session for zone secretaries, zone presidents and commissioners prior to their spring meetings to clarify and discuss motions that will be presented at those meetings. The Executive supported this idea.

7.10 Volleyball creation of ASAA scholarship fund

Idea to offer the scholarship to students who give back to the sport community, coaching or assistant coaching during the three years of high school. Grade 11 or 12 only, had to have played in an ASAA sport at least once during their three years but can be officiating, managing, or coaching. One per zone, with 2 per Edmonton and Calgary because of population differences. Currently all late fees go to AIAAA, cap at \$9000 with everything above that goes to scholarships, and as royalties increase to AIAAA goal wold be for the \$9,000 to be. Idea of a "pay it forward loonie fee" applying to every student athlete at ASAA provincials – would raise about \$7,000/yr for scholarship fund. Sponsor could be searched out as a main contributor. \$100 000 to start for endowment, \$500 per athlete per year which may initially come from ASAA budget, as endowment grows. Executive support \$10,000 in budget; \$5,000 to cover the costs of the scholarship annually and \$5000 to endowment. Should be offered in the same year that loonie fees start so the benefit is seen immediately. Zone can adjudicate; have zones decide on another zone's recipients so there are no vested interests
