Deanna - Football provincials wrapped up this week and it was a huge success. The hosts did a great job with planning; everyone was very pleased with how organized and smooth it was. Gord Bamford sang the national anthem at Tier II Provincial Finals. Meeting with the host for next year was very positive; lots of good ideas including fan packages that will include transportation options. There were a few issues with the a team, including an ejection for language and leaving the change rooms in poor condition. The Principal has been contacted and the ASAA and Host Committee is expecting an apology. Lots to catch up on with basketball. Meeting with ASC on Nov 28 regarding finding funding to provide free NCCP Certification for coaches who qualify. This funding would be \$80 000/year for three years if the proposal is successful (2018/19 on).

John - Deanna and John attended the CAC conference where the MOU between SSC and CAC was signed. They discussed the LMS opportunities available to us and the CAC would like to meet with us to discuss the hosting of school coach on their LMS. We want to explore this option and see what this will look like and what costs and timeline might be. Still waiting on the progress for Making Headway course and possible modification for a school sport audience. SASS Casino went well and we should expect 72,000+ in

revenue. Hosted a meeting with Michelle Ross, Mike and Deanna where we had conversations around the efficiencies and processes of the ASAA and how we can do more to serve our host committees. Milk scholarships were presented a few weeks ago, and John attended several Volleyball Provincials in addition to Football Provincials. Mike - Volleyball was a huge success - the only issue was regarding an incident at the 2A boys event. Ongoing challenges with the website but registration process was simplified this year and the feedback was positive. There were concerns raised about the atmosphere in the MHHS gym because of how large it is which may present a problem for basketball. A few communication challenges with SC.TV and the feedback was consistent across all Volleyball hosts that our contact at the company was not easy to get ahold of for assistance.

Shanna - Cold Lake High school hosted a Unified bean bag tournament and they did an incredible job - in particular the AD Kelly Eagles. They had a partner and athlete sing the National Anthem together which was a very positive experience. They hosted a dance competition to give away free t-shirts, and they also produced custom Unified medals of laser engraved wood. The entire event cost was covered by community donations. They approached the event the same they would as any other school sporting event. Partners were not getting volunteer credits but the student officials did. Tips for making the event better include making sure that the rules are consistent and enforced across all courts. No updates on ordering para equipment due to high volume of work in the office but expects to have things ordered before Christmas and arrived in the office by the end of January.

The Fort McMurray host committee is going to analyze the economic impact of hosting the Alberta Bowl. The hosts are also putting in a lot of effort into looking at travel subsidies to support the event. The Executive consensus was that no change will be made to Fort McMurray hosting Alberta Bowl 2018.
