## GENERAL BYLAW AND POLICY NOTICES

### Notice #1: Policy – Section II –1. General Statements on Discipline, D., page 28-29

#### Current:

D. Behaviour by any member of a team, including all bench personnel, deemed objectionable conduct as defined in the rule book for a sport shall be immediately subject to the penalty prescribed in the rule book for such an offense. In this situation during a game, the head official for the game shall be empowered to see that the penalty is carried out (including ejection of team personnel from the game site) to allow the game to continue or if necessary, to halt further play and award the game to the non-offending team. If an ejection results in a teacher-coach/teacher-supervisor to no longer be present with the team, the game will be forfeited.

#### Proposed:

D. Behaviour by any member of the team, including all bench personnel, deemed objectionable conduct as defined by the rule book for a sport shall be immediately subject to the penalty prescribed in the rule book for such an offense. In this situation during a game, the head official for the game shall be empowered to see that the penalty is carried out (including ejection of team personnel from the game site) to allow the game to continue or if necessary, to halt further play and award the game to the non-offending team. **In the event that a coach or team official is ejected from a game/match/bout, they are required to immediately leave the building until 30 minutes following the conclusion of the game/match/bout.** If an ejection results in a teacher-coach/teacher-supervisor to no longer be present with the team, the game will be forfeited.

#### Rationale:

**The current policy does not articulate the parameters of what it means to eject a coach from a game. The adjustment in policy is to clarify the parameters of an ejection and prevent the confusion that occurred at the 2017 ASAA Basketball Championship from occurring in the future.**

### Notice #2: Policy – Section III –1. High School Membership, C. Online Coach Education, page 35

#### Current:

ii. Every team official (head coach, assistant coach(es) and teacher sponsor) in all ASAA sports must have completed the ASAA's online Concussion course from [www.schoolcoach.ca](http://www.schoolcoach.ca) by one month into their respective Season of Play; this includes every team official who is regularly present with the team during competition. Schools not completing this requirement may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.

#### Proposed:

ii. Every team official (head coach, assistant coach(es) and teacher sponsor) in all ASAA sports must have completed the ASAA's online Concussion course from [www.schoolcoach.ca](http://www.schoolcoach.ca) by one month into their respective Season of Play; this includes every team official who is regularly present with the team during competition. Schools not completing this requirement **will be assessed \$50 per coach not in compliance**, and may lose eligibility for participation in ASAA sanctioned activities; this will be at the discretion of the Executive Committee.

#### Rationale:

**For five years, the ASAA membership has supported online Concussion education for coaches. This safety requirement is intended to provide the safest possible environment for student athletes. Spot checks by the ASAA staff this year determined that many schools are not meeting the requirement for ALL coaches to have taken the concussion course. Because this is a safety matter, the Executive feels that compliance must be enforced; the penalty is seen as one way of doing this.**

### Notice #3: Policy – Section V –Activities, 2. Interschool Competition and Invitational Events (Sanction Policy)- Process for written application for sanction of interschool events, page 52

#### Current:

The result of all written sanction requests processed by the ASAA, approved or not approved, will be posted on the ASAA website. Schools that are invited to participate in an event are responsible for checking the ASAA website for event approval before accepting an invitation. Invited schools have the option of accepting or declining an invitation to a sanctioned event.

ASAA Member Schools: ASAA member schools hosting interprovincial/international events involving three or more school teams in activities of the ASAA must apply for sanction using the *Interprovincial Competition Sanction Form* or, if inviting US teams, the *NFHS Interstate Sanction Form*. The sanction form must be submitted to the ASAA at least 30 days prior to the event. **Beginning 2017/18 school year, a \$200 late sanctioning fee will be assessed to the host school or institution, if sanction form is not submitted in time.**

#### Proposed:

The result of all written sanction requests processed by the ASAA, approved or not approved, will be posted on the ASAA website. Schools that are invited to participate in an event are responsible for checking the

ASAA website for event approval before accepting an invitation. Invited schools have the option of accepting or declining an invitation to a sanctioned event.

1. ASAA Member Schools: ASAA member schools hosting interprovincial/international events involving three or more school teams in activities of the ASAA must apply for sanction using the *Interprovincial Competition Sanction Form* or, if inviting US teams, the *NFHS Interstate Sanction Form*. The sanction form must be submitted to the ASAA at least 30 days prior to the event. **Beginning 2017/18 school year, a \$200 late sanctioning fee will be assessed to the host school or institution, if sanction form is not submitted in time.**
2. ASAA member schools traveling to an out of province or country event must ensure that the event in question is sanctioned by the ASAA through its respective counterpart (province/state) via being posted to the ASAA website. Further, such schools must complete a "Travel Permission" form at least 30 days in advance of the event. Failure to complete this form at least 30 days prior to travel will result in a \$200 late "Travel Permission" fee.

**Rationale:**

Each year there are many school teams that travel to events in other provinces or the United States. The ASAA has reciprocal agreements with provincial school athletic associations across North America that require each of those associations to ensure all events are sanctioned within set timelines and that those events only involve high school teams that are there with the approval of their school. This reciprocal agreement requires document completion by both provincial/state school sport associations, and is for the protection of student athletes by ensuring that an educational institution is controlling the event and that if there is an incident that requires follow up, there is a school sport association that can and will hold schools and post-secondary institutions accountable. This spring, there was an intentional injury at a sanctioned event and the ASAA was able to follow up with a provincial school sport counterpart to ensure appropriate action was taken at the school level to address this matter. Also, each year, the ASAA becomes aware of schools that travel to another province or state and fail to ensure that the host of the event has done their job in having the event sanctioned. ASAA usually finds out days before the event when it receives a panic call. This, in turn, requires significant and immediate chase up time at the ASAA office - often at a time when they should be serving member schools in other ways. Schools traveling outside Alberta need to understand that part of their approvals process to play school sport outside Alberta includes the ASAA. Despite annual reminders of sanctions policy at the zone meetings, it does not seem the message is getting through.

\*\*If the Central and North Central Zones feel that membership on these committees is burdensome for their zones, because there are only two zones in their region, versus three in the others, an alternate rotation could be created to include an out of region zone, on a rotating basis. Utilizing out of region zones that would fit the rotation without placing two reps from the same rotation from the same zone on the same committee.

**Rationale:**

When the current ranking system was drafted and put in place by the boy's basketball commissioner at that time (Terry Hanna), it was seen as a system that would be facilitated by all zones. By facilitated, we mean that all zones would contribute membership to the committees on a regular basis. This way all zones would feel they had a part in the process and committees would not be come "stale", nor could they be accused of developing biases because members had served on a committee for extended lengths of time. Unfortunately, this has not come to fruition as hoped. Many coaches or Athletic Directors do not wish to take on the additional duties of serving on a committee and the time it takes.

To get back to the original intention for the composition of committees, and assure all zones are involved on a regular basis, we feel that a set rotation of membership on the committees will achieve this. It is important to continually bring new rankers into the process, while maintaining a degree of continuity to assure the effectiveness of the committees.

The included rotation is designed to maintain a degree of continuity on each committee, while ensuring that every zone is represented on at least 1 of the 9 committees at all times. We also believe that this rotation will do much to answer the

questions and criticisms we hear regarding the composition of these committees and enable those with a desire to serve on them, the opportunity to do so.

Zone secretaries will provide to the ASAA office a list of zone championship hosts and their home phone numbers in advance of the zone championship tournament weekend so that hosts may be contacted in a timely manner if zone results are not received or more information is needed. 1. Teams in the Final Ranking will be awarded points using a reverse point system. The team ranked #1 earns 15 pts, #2 earns 14 pts, ending with #15 earning 1 pt.

3. In the event of a tie, the zone with the highest ranked 2<sup>nd</sup> team will be awarded the berth (for example, if one zone has the 2<sup>nd</sup> and 5<sup>th</sup> ranked teams and another zone has 3<sup>rd</sup> and 4<sup>th</sup> ranked teams, the zone with the 4<sup>th</sup> ranked team would get the wildcard berth).

4. Vacant Berths

**Rationale:**

Many honourable mention teams do make the provincial championships and the positioning of them in the provincial draw would be much easier if they were ranked in order. Additionally, the change would help rankers be more accurate throughout the entire year when an upset occurs between a top 10 team and a current honourable mention team.

The current policy puts a lot of emphasis on the results of zones and teams who have one poor outing can be eliminated from provincial competitions. One of the main criteria the ranking committee uses for final rankings is the teams body of work, which includes games versus other top teams from other zones. Upsets can occur more frequently at the zone championships between teams who are familiar with one another. For example, this year Cardston was ranked #5 in the final ranking, but finished 4th in their zone tournament. They still qualified for provincials as the 10th seed, but if provincials would have been hosted in another zone, they would have been eliminated from provincials. \*if either of the zones does not have a registered team, there would only be one representative and the other berth would become a fourth wildcard berth and awarded according to Item 7. Awarding Wildcard Berths, pages 83-84. An Edmonton & Central Zones tournament is used to determine the champions of each zone, as well as two berths to provincials. The tournament will be hosted by the Edmonton Zone at least once every four years. The rankings for the tournament will be based on the provincial rankings if possible and the schedule is to be approved by both zones before being finalized.

\*\*The top two teams at the conclusion of the tournament would qualify for provincials regardless of which zone they are from. Wildcards will be awarded to the Central Zone and Edmonton Zone independently according to Item 7. Awarding Wildcard Berths, pages 83-84. If either zone cannot fill their wildcard with a team from their zone, the berth will be vacated as per policy

**Rationale:**

Due to lack of teams, the Edmonton Zone does not require an appropriate provincial qualification playoff at the 1A level for volleyball and basketball. Therefore the correct mindset towards earning a berth at volleyball and basketball provincials is not being fostered in the minds of the student athletes from the 1A Edmonton Zone. The ASAA endorses healthy competition in order for a team to qualify for provincials. This proposal forces the Edmonton Zone to send a worthy representative.

Unlike the Edmonton Zone, the Central Zone has by far the most amount of teams competing for provincial berths. This proposal would help to equalize the opportunities for student athletes, teams and schools from across the province, and specifically the zones involved, to qualify for provincials.

Percentage of eligible teams compared to guaranteed berths to provincials (before wildcards). Stats from the 2016-2017 school year, including both sports and both genders:

As shown by the percentages above, Edmonton has an automatic berth into provincials and the Central Zone has double the teams of most zones. If the two zones were to compete with each other for two berths, the percentage of teams qualifying for provincials would be fairer for all involved.

The South, Edmonton and Calgary Zones are able to get their basketball communities excited about the provincial championships through very competitive zone championships. It trickles down to the younger players who will someday play in it and hopefully provincials. This type of tournament would allow the other 4 zones to have a competitive competition with each other, and help grow the sport in their communities. Teams would have a chance to win a provincial banner for their school and earn a trip to 4A provincials. The average score difference per game, the last two years was:  
 #16 seed – -32 pts (boys); -56 pts (girls)  
 #15 seed – -20 pts (boys); -47 pts (girls)  
 #14 seed – -22 pts (boys); +2 pts (girls)

The requirement of five judges is also based on the older judging system where five judges each gave an overall score and the highest and lowest scores were then eliminated. In the new judging system, implemented three years ago, judges are each assigned a section of the score sheet to judge. This new system only requires three judges, though five are often used at the beginning of the season when the score sheet has been updated, and as a training method for new judges. With the increased focus on judge education and training, the panel of five judges is being reduced to three more often, especially at end-of-the-season events.**

It was useful to have a years leeway as a transition but these rules are now a regular part of competitive curling and Curling Canada rules and ASAA should follow suit at our high school championships. Approved brush heads are manufactured by all curling equipment companies, widely available, and cost about \$30

**Rationale:**

The overall rationale for this change is to eliminate (or reduce the likelihood) of the regularly occurring date conflict between the ASAA Curling Provincial Championships and the Alberta Curling Federation U-18 Curling Provincial Championships. Due to the timing of the qualifiers, teachers/coaches are forced to enter teams into ASAA Zone qualifying events without knowing if their key players (often their Skips and Thirds) will be available to play. On a regular basis, teams find out midway through qualifying that they will lose players. This serves as a major demotivating factor for these teams. To avoid this possibility, some teachers are making the tough decision to not even enter a team into ASAA competition because their key players are favourites to qualify for U-18 Provincials. These decisions limit the opportunities for their students.

With other sports, missing one or two teammates can be challenging but curling teams are only 4 in size. Losing a Skip or Third is crippling. Qualifying schools often do not even have extra players to replace their original players and must therefore drop out of their ASAA zone qualifiers. It can also cause financial burdens on parents who do not want to pay for their children to compete on a school team if they are only part of that team for a limited number of games.

This conflict causes major stress and disappointment for teachers/coaches who volunteer their time only to have their players taken out from under them at the last moment. There already exists a rule limiting the participation of curlers who qualify for Alberta Curling Federation Junior Provincial Championships, so there can be no argument that the U-18 Provincials conflict is ‘ok because the elite have other opportunities in club competition.’ Lastly, the conflict calls into

**Rationale:**

After 20 plus years of not entering Curling, the Calgary zone will be doing so starting next year. Previously, the Calgary Zone spots were given to the host school as host berths. In order to provide host schools with berths at provincials, the draw will need to be changed from 8 to 10 teams to accommodate host schools. Adding only one spot (9) does not work for curling draws; 10 will provide host schools with a spot and also a wildcard spot. This change will require that provincial championships start earlier than at present. The first draw will need to be Thursday morning, rather than the Thursday afternoon start currently in place. This will make it difficult for towns with fewer than 8 sheets of ice to host provincials, but is necessary to allow all zones to be represented and return ASAA curling to a true provincial championship.

        4. 1 vs 2 crossover playoff game – the team which finished first in their pool will be rewarded with hammer in this game, thus the extra delivered stone is not required as part of the practice. **The team with hammer received first practice, the other team selects rock colour.**
        5. **For the medal games, the team with the lower combined total from the draws to the button from the round robin games will be awarded hammer and first practice. The other team will select rock colour and have second practice.**

**Rationale:**

Changing the time from 20 minutes to 30 minutes will help keep the event on schedule. A 5 minute practice plus a draw to the button plus time for teams to leave the ice and the second practice to get to the ice quickly eats up the current 15 minute time allotted for practices.

Changing what the coin toss winner can select aligns ASAA championships with current Curling Canada practices.

The rest of the proposed changes clarify the process for determining hammer in the round robin, semi-final, and medal games. Changes or addition of language addresses confusion experienced this year at provincials as how the previous rules were to be followed and aligns ASAA championships with current Curling Canada practices.

Process for determining hammer in the medal games was not previously established.

In keeping in line with the ASAA mandate of "Each season of play shall be approximately 16 weeks in duration (school time) with holiday periods taken into consideration where applicable" (Page 54 Section C). At present, the Golf season of play is the shortest of all our sports, lasting only 12 weeks. Two of those weeks, students are in final exams. Examples of cross country and football which are presently allowed to begin practice starting August 16.

Cross Country – The season of play for Cross Country shall be May 1 to the provincial championships on the third Saturday in October. The season of play is not intended to include July and August. Practice in the fall may begin August 16.

Football – The season of play for Football shall be May 1 to the provincial championship to be held no later than the fourth Saturday in November and the preceding Friday night. The season of play is not intended to include July and August. Teams may begin practice in the fall, starting August 16.

##### Rationale:

The current policy states that handball provincials are to be run as a two day event. The first year of handball as an ASAA sport in 2009/10, the event was combined with Tier I & Tier II and was run over 3 days. The next 2 years (2010/11 and 2011/2012) the event remained combined and was run over only 2 days. Beginning with the 2012/13 Championship & continuing into 2016/17, Tier I & Tier II have been split. Since this split, the Tier I Championship has reverted back to a 3 day event to avoid teams playing more than 2 games in a day. The Tier II Championship remained a 2 day event until 2015/16 when it was run over 3 days. This was not put into policy, however, so the 2016/17 championship reverted back to a 2 day event.

Teams must play 3-5 games at the event and for provincial caliber games, having to play 3 games in a day is not ideal for top performance. Basketball for example, requires teams to play 2 games at most in a day.

Tier I teams currently expect their championships to run over 3 days so the change in policy would make it official for them. For Tier II, it would be a change in the schedule going forward. The tournament banquet would be held Thursday afternoon as a lunch event, with photos, captains/coaches meeting to follow and games would start around 3:00 Thursday, and run all day Friday & Saturday.

Handball has been struggling to find hosts for its championships so should a host be unavailable to start games on Thursday due to facility availability, the event could be condensed with Executive & Commissioner approval.

F. A team must start every match with 6 eligible players. In the event of an injury where a team has no eligible players available, the team may continue play with five players. The position in rotation that becomes vacant remains in the same rotational position and continues in the rotational order. Therefore, if the vacant position is in the front row, there are only two front row players, similarly in the back row. A point and the ball is awarded to the opposition when the vacant spot rotates into position one.

**Rationale:**

It is not in an injured player's best interest to remain on the court to prevent team disqualification. To default a team for injury does not support the philosophy that we provide opportunity for athletes.

**Rationale:** Due to a lack of teams, the Edmonton Zone does not require an appropriate provincial qualification playoff at the 1A level for volleyball and basketball. Therefore the correct mindset towards earning a berth at volleyball and basketball provincials is not being fostered in the minds of the student-athletes from the 1A Edmonton Zone. The ASAA endorses healthy competition in order for a team to qualify for provincials. This proposal forces the Edmonton Zone to send a worthy representative.

Unlike the Edmonton Zone, the Central Zone has by far the most amount of teams competing for provincial berths. This proposal would help to equalize the opportunities for student-athletes, teams and schools from across the province, and specifically the zones involved, to qualify for provincials.

As shown by the percentages above, Edmonton has an automatic berth into provincials and the Central Zone has double the teams of most zones. If the two zones were to compete with each other for two berths the percentage of teams qualifying for provincials would be fairer for all involved.

#### Rationale:

Alberta is the only province which requires wrestlers to wear mouth guards in high school competition. They are used more for dental protection than concussion protocol. Athletes and parents still have the option of wearing the mouth guard at their discretion.
